ORDINANCE NO. 26

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 15 OF THE BOROUGH OF INDIAN LAKE KNOWN AS THE "ORDINANCE ACCEPTING AND ORDAINING AS PUBLIC STREETS CERTAIN OPEN STREETS IN THE BOROUGH OF INDIAN LAKE, SOMERSET COUNTY, PENNSYLVANIA."

Section 1: The following named streets, which are hereby designated as so named as hereinafter set forth, are hereby accepted and ordained as public streets in the Borough of Indian Lake, Somerset County, Pennsylvania:

RIGHTS OF WAY 50 FEET WIDE:

South Shore Trail from the western edge of Ottawa Park a distance of 5,131.10 feet to the northeastern edge of Delaware Park.

The total distance of the rights of way hereinabove described 50 feet in width is 83,475.95 feet or 15.80 miles, with a total area thereof being 95.81 acres.

RIGHTS OF WAY 33 FEET WIDE:

None

RIGHTS OF WAY 20 FEET WIDE:

Cayuga Lane 863.30 feet
Navajo Lane 415.80 feet
Syracuse Path 549.60 feet

The total distance of the rights of way hereinabove described 20 feet in width is 15,644.50 feet or 2.96 miles, with a total area thereof being 7.180 acres.

AMENDED TO READ AS FOLLOWS:

Section 1: The following named streets, which are hereby designated as so named as hereinafter set forth, are hereby accepted and ordained as public streets in the Borough of Indian Lake, Somerset County, Pennsylvania:

RIGHTS OF WAY 50 FEET WIDE:

South Shore Trail Extension from the western edge of Ottawa Park a distance of 1,030.8 feet to the southern Boundary of Indian Lake Borough. Total feet - 6,161.90

RIGHTS OF WAY 50 FEET WIDE ADDITIONS:

Peninsula Drive Extension from the end of Peninsula Drive a distance of 2,270.11 feet to the eastern Boundary of Indian Lake Borough.

Peninsula Entrance Road from its intersection with Peninsula Drive Extension a distance of 687.0 feet to the northern Boundary of Indian Lake Borough.

Cayuga Circle from its intersection with Peninsula Drive a distance of 863.3 feet to its place of beginning.

The total distance of the rights of way hereinabove described 50 feet in width is 93,007.31 feet or 17.62 miles, with a total area thereof being 106.76 acres.

RIGHTS OF WAY 33 FEET WIDE ADDITIONS:

Syracuse Path from its intersection with West Shore Trail a distance of 615.06 feet to Lot No. 9 in Navajo Park.

The total distance of the rights of way hereinabove described 33 feet in width is 615.06 feet or 0.12 miles, with the total area thereof being 0.47 acres.

RIGHTS OF WAY 20 FEET WIDE ADDITIONS:

Pueblo Path a distance of 515.8 feet.

RIGHTS OF WAY 20 FEET WIDE DELETIONS:

Cayuga Lane a distance of 863.3 feet

Navajo Lane a distance of 100.0 feet

Syracuse Path a distance of 549.60 feet OK- OPENED 1976

The total distance of the rights of way hereinabove described 20 feet in width is 14,647 feet or 2.77 miles, with the total area thereof being 6.73 acres.
