It's not the length of the boat, it's the hp and speed.

NO WAKE BOATS OR LIMIT IN BEST*** TO INTENTIONLLY CREATE A TSUNAMI WAKE!

We need to get back to Safer Boating!

Waves from wake surfing activity is excessive, when too close to shore or other boats.

LIMIT TOTAL # OF POWER BOATS ALLOWED TO REGISTER

We need to reduce the size of the wakes on the lake by any means.

NO WAKE BOATS LAKE IS TOO SMALL

NOTE DURING THE RECENT 4TH OF JULY, IT WAS NOTED THAT MANY BOATS LOADED TO CAPACITY FORMED LARGE WAVES/WAKES EQUIVALENT TO WHAT HAS BEEN REFERRED TO HERE AS A 'WAKE ENHANCED' BOATS, ANY FULL LOADED BOAT COULD BE CONSIDERED A "WAKE ENHANCED' BOAT. EVEN THE POLICE BOAT WHICH TRAVELED AT PLOWING SPEED THAT WEEKEND PRODUCED A WAKE EQUIVALENT TO THE "WAKE ENHANCED" BOATSS THAT WERE ON THE LAKE THAT WEEKEND.

Most lakes our size outlaw wake boats.

Depth of water 30 ft

WAKE BOATS SHOULD NOT BE PERMITTEDE AT ALL

Only because there is no way to know what the impact is. Might be okay if these came with limits similar to those from the MFG.

Manufacturers keep increasing weight. Limit necessary on our size lake.

FORS THE SUMMMER WE LET PEOPLE ENJOY THEMSELVES! STOP OVER POLITING AND STOP ALL OF THE REDICULOUS ORDINANCES.

NO ADDITIONAL BALLAST APPROVED OR NOT

don't know enough about weight
